**WHEREAS**, DILG Memorandum Circular No. 2015-128 dated November 2, 2015 re Guidelines on the Formulation of Peace and Order Council and Public Safety (POPS) Plan mandates every provincial, city and municipal Peace and Order Council and Barangay Peace and Order Committee to formulate a 3-year term-based Peace and Order and Public Safety (POPS) Plan which shall be incorporated in the Comprehensive Development Plan of the local government unit;

**WHEREAS**, the City Peace and Order Council, Technical Working Group, Sangguniang Panlungsod Committee on Peace and Order and other stakeholders conducted a workshop on the formulation of the Peace and Order and Public Safety (POPS) Plan for the Year 2023-2025 on October 2022;

**WHEREAS**, after due deliberation of the presented POPS Plan 2023-2025, the CPOC members consider its approval;

**NOW THEREFORE**, on motion of Councilor Alejandro Gutierrez and duly seconded by JCI Elaine D. Toledo, be it;
