A RESOLUTION DISMISSING THE COMPLAINT OF MS. SHIELA MARIE R. REAMBONANZA AND MS. EDELITA L. REGACHO OF BARANGAY PANAPAAN IV, BACOOR CITY, CAVITE AGAINST PUNONG BARANGAY CARLITO GALVEZ, ET.AL., OF THE SAME BARANGAY DUE TO THE AMICABLE SETTLEMENT OF THE SAID DISPUTE.

WHEREAS, a complaint was filed by Ms. Shiela Marie R. Reambonanza and Ms. Edelita L. Regacho of Barangay Panapaan IV, Bacoor City, Cavite, (the "complainants") against Punong Barangay Carlito Galvez, and Barangay Officials Yolanda Colita, Diana Ferrer, Jay Nunez And Danilo Cuello, all of the same barangay (the "respondents") for alleged abuse of authority and collusion to pin false accusation of direct assault.

WHEREAS, the said matter was referred to the Committee on Ethics, Appointment and Government Re-organization and the Committee on Barangay Affairs for appropriate action.

WHEREAS, the Committee on Ethics, Appointment and Government Re-organization and the Committee on Barangay Affairs conducted a series of hearings attended by the above-mentioned parties with regard the said allegation. At the end of the said hearings, the parties agreed to amicably settle their differences and jointly moved for the dismissal of the said complaint.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously duly seconded by the rest of the council in regular session duly assembled, **DE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor to **DISMISS** the
