**A RESOLUTION AUTHORIZING CITY MAYOR, HON. STRIKE B. REVILLA TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOOD AND THE PHILIPPINE NATIONAL POLICE FOR THE USE, FREE OF CHARGE, OF A PORTION OF THE BUILDING OF THE BACOOD COMMAND CENTER AT BARANGAY BAYANAN, BACOOD CITY AS THE PRIMARY SITE OF THE MAIN POLICE STATION.**

**WHEREAS**, the Philippine National Police (PNP) is mandated to enforce the law, maintain peace and order, and ensure public safety and internal security throughout the country.

**WHEREAS**, the City Government of Bacoor recognizes the need for a strong and effective police force in maintaining peace and order, protecting the safety and security of the residents of the City, and promoting a conducive environment for economic growth and development.

**WHEREAS**, the City Government of Bacoor, through the City Mayor, Hon. Strike B. Revilla, has offered a portion of the building of the Bacoor Command Center at Barangay Bayanan, Bacoor City as the primary site of the main police station of the Bacoor City Police Station.

**WHEREAS**, the PNP has accepted the offer and a Memorandum of Agreement embodying the agreement has been drafted. Said draft Memorandum of Agreement is deemed incorporated herein and made an integral part of this Resolution.

**WHEREAS**, the use of a portion of the building of the Bacoor Command Center as the primary site of the main police station will provide a convenient and accessible location for the PNP to perform its mandate in the City of Bacoor.

**WHEREAS**, under the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign on its behalf all contracts upon the authority of the Sangguniang Panlungsod. Moreover, no contract may be entered into by the

## MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement, made and executed this \_\_\_\_ day of February 2023 at Bacoor City, by and between:

**THE CITY GOVERNMENT OF BACOOR**, a local government unit created and existing under Philippine Laws, with principal office address at the Bacoor Government Center, Brgy. Bayanan, Bacoor City, herein represented by its City Mayor, **HON. EDWIN "STRIKE" BAUTISTA REVILLA**, referred to as the "**CITY**";

-and-

**THE PHILIPPINE NATIONAL POLICE**, created and existing under Philippine Laws, with principal office address at Bacoor Command Center, Bacoor Government Center, Brgy. Bayanan, Bacoor City, Province of Cavite, herein represented by its Acting Chief of Police, **PLTCOL RUTHER D SAQUILAYAN**, and hereinafter referred to as the "**PNP**"

WITNESSETH: - That

WHEREAS, the CITY has fully recognized the need for a MAIN Police Station, that will benefit the constituents of the City of Bacoor as well as tourists coming into the City;

NOW, THEREFORE, for and in consideration of the above premises, both parties agreed to bind themselves to this agreement, subject to the following terms and conditions:

1. The CITY shall allow PNP to use, free of charge, as site of the MAIN Police Station, a portion of the building of Bacoor Command Center owned by the City Government of Bacoor located in Brgy. Bayanan ; Bacoor City.
2. The PNP shall assign and maintain the required reasonable number of PNP personnel as dictated by the needs of the center.
3. The Agreement shall take effect upon signing and shall remain valid, existing and binding until such time that either the CITY and/or the PNP shall express its desire to terminate or suspend implementation of this agreement subject to a 30-day prior written notice to other party.


