A CITY RESOLUTION ENDORSING THE FOLLOWING PROJECTS NAMELY: (1) SOLAR POWERED WATER STATION WITH FILTRATION PROJECT AT RESPONSIBLE VILLAGE LEADERS LEARNING ACADEMY (REVILLA) HIGH SCHOOL, BARANGAY MALIKSI I, CITY OF BACOOR, CAVITE, AND (2) SOLAR POWERED WATER STATION WITH FILTRATION PROJECT AT BAYANAN ELEMENTARY SCHOOL, BARANGAY BAYANAN, CITY OF BACOOR, CAVITE AMOUNTING TO TEN MILLION PESOS (PHP10,000,000.00) BY THE LOCAL GOVERNMENT OF THE CITY OF BACOOR TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR THE AVAILMENT OF THE LOCAL GOVERNMENT SUPPORT FUND FINANCIAL ASSISTANCE (LGSF-FA) OF REPUBLIC ACT NO. 11639 OR THE GENERAL APPROPRIATIONS ACT (GAA) FOR FISCAL YEAR 2022.

WHEREAS, pursuant to Special Provision No. 2 of the 2022 General Appropriations Act (also known as Republic Act No. 11639), the amount appropriated for the Local Government Support Fund - Financial Assistance (LGSF-FA) are (1) Five Billion Five Hundred Eighty Three Million Three Hundred Ninety Six Thousand Pesos (**PhP5,583,396,000.00**) and (2) Five Billion Seven Million Six Hundred Thousand Pesos (**PhP5,007,600,000.00**) for support for Capital Outlays and Social Programs to Local Government Units (LGUs).

WHEREAS, the Department of Budget and Management's (DBM) Local Budget Circular No. 142 dated January 24, 2022 provides the guidelines on the release and utilization of the Local Government Support Fund-Financial Assistance (LGSF-FA) to Local Government Units and support for Capital Outlays and Social Programs under the FY 2022 GAA or RA No. 11639.
