A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE MEMORANDUM OF AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOR AND THE DBDOYC, INC. (DOING BUSINESS KNOWN AS "ANGKAS"), RELATIVE TO THE PROMOTION OF GENERAL WELFARE BY PROVIDING MOTORCYCLE RIDERS FROM THE CITY OF BACOR WITH BASIC TRAINING AND EDUCATION ON MOTORCYCLE DRIVING SAFETY.

WHEREAS, the DBDOYC, Inc. a domestic corporation doing business as a motorcycle taxi-hailing company and better known as "ANGKAS", proposed a partnership with the City Government of Bacoor to promote general welfare by providing motorcycle riders based in the City of Bacoor with basic training and education on motorcycle riding safety.
