RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO HIRE CONSULTANTS THAT WILL ASSIST THE CITY GOVERNMENT IN OBTAINING ISO 9001 CERTIFICATION PURSUANT TO THE CONTINUING EFFORTS OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR TO IMPROVE ITS DELIVERY OF PUBLIC SERVICES.

WHEREAS, though the local government of the City of Bacoor, Cavite has consistently been awarded a Seal of Good Local Governance by the national government for many years, Mayor Strike B. Revilla continues to look for ways to further improve the delivery of various services to the public and instill a culture of integrity, competence, and dedication in the hearts and minds of all city government employees and officials.

WHEREAS, to make his dream of improving the manner by which the local government of the City of Bacoor serves its constituents, the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing him to hire consultants that will assist the city government obtain an ISO 9001 Certificate and help develop a Quality Management Manual to be used by city government officials.

WHEREAS, Republic Act No. 9184 (the "Government Procurement Reform Act") allows local government units to hire consultants especially if no employee or official of a particular LGU is capable or qualified to perform the task to be done by the said consultant/s.

WHEREAS, considering that his proposal that the city government should obtain an ISO 9001 Certification is commendable because it will most likely result in a marked improvement in the way the city government operates, and the fact that the city government has no employee or official qualified or capable of assisting the local government obtain the said ISO 9001 Certification, the members of the Sangguniang Panlungsod collectively believe that the City Mayor should be authorized to hire consultants that will assist the city government in its bid to secure the said certification.

NOW THEREFORE, upon motion of Hon. Alejandro F. Gutierrez duly seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the City Mayor, Hon. Strike B. Revilla, to hire consultants that will assist the city government its bid to secure the ISO 9001 certification subject to
