**WHEREAS**, pursuant to the provisions of Republic Act No. 8792 otherwise known as the "Electronic Commerce Act of 2000" which aims to facilitate commercial and non-commercial electronic transactions and "promote the universal use of electronic transactions in government and the general public", the City Government of Bacoor intends to use the electronic payment facility as an alternative method for disbursements and collections of the city.

**WHEREAS**, the Philippine Payments and Clearing System (PhilPaCS) is a technology solutions supplier partly owned by the Land Bank of the Philippines (Landbank) and is providing Local Government Units (LGUs) with appropriate digital technology solutions to upgrade institutional capability for seamless online payment, collection and receipting systems listed in **Landbank's Electronic Payment Portal (LinkBiz Portal)**.

**WHEREAS**, the PhilPaCS offered its platform to the City Government of Bacoor namely: (1) **CheckUrBill** for real-time online billing presentment (Electronic e-Bill Presentment); and (2) **eOR** (e-Receipting System) for taxes, fees and other local monetary impositions.
