A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN CONTRACTS OF SALE WITH THE WINNING BIDDERS IN THE PUBLIC AUCTION OF UNSERVICEABLE PROPERTIES OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE.

WHEREAS, pursuant to Section 375 (d) of Republic Act No. 7160 and the National Government Accounting System (NGAS) Manual for Local Government Units, the Office of the City Mayor issued Executive Order No. 2, Series of 2012, creating the Bacoor Inventory and Appraisal Committee.

WHEREAS, on 29 July 2022, the said committee was reorganized and renamed as the Bacoor City Inventory, Appraisal, and Property Disposal Committee (BCIAPDC) through Executive Order No. 18, Series of 2022.

WHEREAS, the BCIAPDC was directed by the City Mayor to begin preparing for the public auction of various unserviceable properties of the City Government.

WHEREAS, one of the matters that must be prepared prior to the holding of the said public auction is the template for the contracts of sale that the City Mayor must sign with the winning bidders during the said public event.

WHEREAS, a draft template of the said Contract of Sale was submitted by the Office of the City Mayor for the review of the Sangguniang Panlungsod. A copy of the said draft Contract of Sale is attached hereto and made an integral part of this Resolution.

WHEREAS, Section 8 (1) (vi) of Republic Act No. 10160 (the "Charter of the City of Bacoor") empowered the City Mayor to represent the City in all business transactions and to sign on its behalf all bonds, contracts and obligations, and such other documents as may be authorized by the Sangguniang Panlungsod.

WHEREAS, upon review of the said template, the Sangguniang Panlungsod decided to approve the same and to authorize the City Mayor to sign it but only if the final version of the said template shall conform with the provisions of various pertinent laws and government regulations.
