A RESOLUTION AMENDING CITY RESOLUTION NO. 2022-051 ENTITLED: "A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION (DOTR) REGARDING THE TRANSFER OF FUNDS TO THE CITY OF BACOR FOR THE LAND ACQUISITION AND ROAD CONSTRUCTION OF NIOG ACCESS ROAD IN RELATION TO THE LRT PROJECT IN THE CITY OF BACOR CAVITE" REGARDING ON THE INCREASE OF CITY GOVERNMENT'S FUNDINGS.

WHEREAS, the Sangguniang Panlungsod passed and enacted City Resolution No. 2022-051, Series of 2022, or "A Resolution Authorizing the City Mayor to Sign a Memorandum of Agreement with the Department of Transportation regarding the Transfer of Funds to the City of Bacoor for the Land Acquisition and Road Construction of Niog Access Road in Relation to the LRT Project in the City of Bacoor Cavite."

WHEREAS, the said Memorandum of Agreement stipulated that the National Government would transfer Two Hundred Forty Million Pesos (PHP 240,000,000.00) to the City of Bacoor for land acquisition and for the construction of the Niog Access Road that may be affected by the Construction of the LRT I South (Cavite) Extension Project in Bacoor City, Cavite.

WHEREAS, on June 16, 2023, the Office of the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting that the aforementioned Resolution be amended to reflect a recent change in the allotment for the said project.

WHEREAS, due to an amendment to the General Appropriations Act carried out by Congress, the initially stipulated amount has been increased to Three Hundred Million Pesos (PHP 300,000,000.00), with an additional provision for supplemental funding to be possibly given by the National Government to the City Government of Bacoor.

WHEREAS, these changes require an amendment to City Resolution No. 2022-051 to reflect the updated funding and to maintain the accuracy of the City's public records and legislation.

WHEREAS, in compliance with Section 8 (b) (1) (vi) of Republic Act No. 10160 (the "Charter of the City of Bacoor"), the City Mayor is endowed with the power to represent the City in all its business transactions and sign on its behalf all contracts, provided such authority is granted by the Sangguniang Panlungsod.

NOW THEREFORE, upon motion of Hon. Roberto Advincula unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to:

1. Amend City Resolution No. 2022-051 to reflect the increase in funding from Php 240,000,000.00 to Three Hundred Million Pesos (PHP 300,000,000.00) and the possibility of supplemental funding from the National Government; and
2. Authorize the City Mayor to sign the amended Memorandum of Agreement between the City Government of Bacoor and the Department of Transportation regarding the transfer of funds to the city of bacoor for the land acquisition and road construction of Niog Access Road in relation to the LRT Project in the City of Bacoor Cavite, provided that the amended Memorandum of Agreement accurately states the increased amount of Three Hundred Million Pesos (PHP 300,000,000.00) and the possibility of supplemental funding from the National Government.

RESOLVED LASTLY, to furnish the Department of Transportation, the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
