A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-286 ENTITLED: "A RESOLUTION AUTHORIZING THE PURCHASE OF FIVE MOTOR VEHICLES BY THE GENERAL SERVICES OFFICE (GSO) IN SUPPORT OF THE PEACE AND ORDER/ PUBLIC SAFETY PROGRAM OF THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE" REGARDING CHANGES IN THE SPECIFICATION OF THE FOUR (4) MULTIPURPOSE VEHICLES.

WHEREAS, on August 1, 2023, the Office of the Sangguniang Panlungsod received a request from the Office of the City Mayor, seeking the amendment of City Resolution No. 2023-286 which authorized the purchase of five (5) motor vehicles by the General Services Office (GSO), with the aim of reinforcing the Peace and Order/Public Safety Program, particularly pertaining to the specification of the four(4) multipurpose vehicles.

WHEREAS, the previously stated City Resolution No. 2023-286 earmarked a budget of Four Million Eighty Eight Thousand Five Hundred and Twenty pesos (PHP 4,088,520.00) for the acquisition of these four multipurpose vehicles.

WHEREAS, in adherence to the Department of Interior and Local Government (DILG) Memorandum Circular No. 2022-105, it has been discerned that the actual amount necessitated for the procurement of these vehicles is Php 4,337,160.00, an adjustment that warrants the amendment of the said resolution.

WHEREAS, prudently ensuring fiscal responsibility, the Office of the City Accountant has offered certification that the requisite funds for procuring these vehicles are indeed available and allocated appropriately within the city's budget.

WHEREAS, the amendment to the specifications and the accompanying budget adjustment is pivotal to ensuring that the multipurpose vehicles procured align with the stipulated standards and serve their intended functions in promoting peace and order, as well as public safety in the City of Bacoor.

WHEREAS, it remains the fiduciary duty of the City Government of Bacoor, under its charter and prevailing statutes, to


