WHEREAS, Municipal Ordinance No. 12-A, Series of 2010 has been enacted to recognize the dedication and unwavering service of Punong Barangay Chairpersons and Barangay Kagawads who have completed their terms with full commitment to their duties and responsibilities.

WHEREAS, under the provisions of Municipal Ordinance No. 12-A, Punong Barangay Chairpersons who have completed three consecutive terms and will no longer be running in the incoming barangay elections are entitled to cash incentives amounting to One Hundred Thousand Pesos (PHP 100,000.00).

WHEREAS, the same ordinance states that Punong Barangay Chairpersons who have completed two consecutive terms and will no longer be running in the upcoming barangay elections are entitled to a cash incentive of Ten Thousand Pesos (PHP 10,000.00).

WHEREAS, Barangay Kagawads who have completed three consecutive terms and who will no longer be running in the upcoming barangay elections are also entitled to a cash incentive amounting to Twenty Thousand Pesos (PHP 20,000.00).

WHEREAS, the awarding of these incentives is subject to the availability of funds, serving as a token of appreciation
