**A RESOLUTION AUTHORIZING THE PROCUREMENT OF THREE (3) FIRETRUCKS, ONE (1) VAN, AND ONE (1) HEAVY CARGO TRUCK FOR THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE UNDER THE TRUST FUND FROM THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM).**
