WHEREAS, the Sangguniang Panlungsod passed City Resolution No. 2014-44A, Series of 2014 entitled, "A Resolution Lifting the Moratorium on the Establishment of Gasoline Stations within the City of Bacoor, Cavite" dated 04 August 2014.

WHEREAS, Ms. Irene Roque of Uno Fuel Inc. intends to establish and operate a gasoline station along the Bacoor-Dasmariñas Road, Barangay Molino IV, Bacoor City, Cavite.

WHEREAS, after a thorough deliberation on the said matter, the majority of the members of the Sangguniang Panlungsod of Bacoor City, Cavite during its regular session decided not to pose any objection to the granting of a business permit by the City Mayor to the above mentioned corporation to allow the latter to establish and operate a gasoline station along Bacoor-Dasmariñas Road, Barangay Molino IV, Bacoor City, Cavite subject to strict compliance with the various provisions of the Zoning Ordinance and policies of the City of Bacoor, the provisions of the National Building Code, and other relevant laws.
