A RESOLUTION ENDORSING ADDITIONAL PROPOSED PROJECTS AMOUNTING TO FOUR MILLION SIX HUNDRED THOUSAND PESOS (PHP4,600,000.00) BY THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR THE AVAILMENT OF THE LOCAL GOVERNMENT SUPPORT FUND - FINANCIAL ASSISTANCE (LGSF-FA) TO LOCAL GOVERNMENT UNITS UNDER REPUBLIC ACT NO. 11936 (THE "GENERAL APPROPRIATIONS ACT FOR FISCAL YEAR 2023").

WHEREAS, the national government appropriated One Billion Nine Hundred Twenty Five Million Five Hundred Thousand Pesos (**PhP1,925,500,000.00**) for financial assistance to Local Government Units (LGUs) and Seven Billion Two Hundred Thirty Six Million Three Hundred Thirty Six Thousand Pesos (**PhP7,236,336,000.00**) for support for Capital Outlays and Social Programs to LGUs pursuant to Special Provision (SP) No. 1 of the Local Government Support Fund- Financial Assistance (LGSF-FA) under Republic Act No. 11936 or the "General Appropriations Act for Fiscal Year 2023".

WHEREAS, the Department of Budget and Management's Local Budget Circular No. 150 dated March 8, 2023 provides the guidelines on the release and utilization of the Local Government Support Fund-Financial Assistance (LGSF-FA) to Local Government Units and support for Capital Outlays and Social Programs under FY 2023 General Appropriations Act or known as the Republic Act No. 11936.

WHEREAS, the additional priority projects/programs/activities amounting to **Four Million Six Hundred Thousand Pesos (PhP4,600,000.00)** were proposed by the city government to be funded under the LGSF-FA to wit:
