**CITY RESOLUTION NO. 2023-348  
Series of 2023**

**A RESOLUTION DECLARING THAT SOLIDARITY ROUTE STICKERS ISSUED BY THE LOCAL GOVERNMENT OF THE CITY OF BACCOOR, CAVITE PRIOR TO SEPTEMBER 30, 2023 SHALL ONLY REMAIN VALID UNTIL DECEMBER 31, 2023.**

**WHEREAS**, City Ordinance No. 255-2023 (the "2023 Expanded Solidarity Route Ordinance") did not provide how long the Solidarity Route stickers issued prior to September 30, 2023 - the date when the newly designed Solidarity Route Sticker was launched — will remain valid.

**WHEREAS**, the new Solidarity Route sticker contain security features that will prevent tampering, misuse, and falsification. The said security features cannot be found in the old design of the said stickers.

**WHEREAS**, in order to prevent the possible use of the Solidarity Route stickers issued prior to the launching of the new design, it is necessary to take them out of circulation.

**NOW THEREFORE**, upon motion of Hon. Robert L. Advincula, duly seconded by Hon. Reynaldo D. Palabrica **BE IT RESOLVED** by the 5th Sangguniang Panlungsod in regular session duly assembled to declare that all Solidarity Route stickers issued by the local government of the City of Bacoor, Cavite prior to September 30, 2023 shall only remain valid until December 31, 2023.


**RESOLVED FURTHER** that copies of this Resolution shall be posted the bulletin boards of all barangays in the City and shall be furnished to the President of all homeowners associations in the City of Bacoor, Cavite.


