**A RESOLUTION EXEMPTING ALL JUDGES ASSIGNED AT THE CITY OF BACOR, CAVITE FROM COMPLIANCE WITH THE DOCUMENTARY REQUIREMENTS FOR THE ISSUANCE OF THE SOLIDARITY ROUTE STICKER AS PROVIDED UNDER CITY ORDINANCE NO. 255-2023.**

**WHEREAS**, Sections 3 and 8 of City Ordinance No. 255-2023 provides that only persons residing in the City of Bacoor, Cavite shall be entitled to obtain a Solidarity Route sticker and that motorists who does not reside within the City must pay P3,000.00 and submit various documents in order to get a copy of the said stickers.

**WHEREAS**, Section 6.1 of City Ordinance No. 255-2023 provides that the following are exempted from the rules enumerated in Section 6 hereof:

1. Properly marked government-owned vehicles used only in official government business;
2. Vehicles used as public utility vehicles such as but not limited to tricycles or other modes of transportation legally allowed to transport persons or cargo within the residential subdivisions covered by this Ordinance in accordance with prevailing laws and rules;
3. Vehicles used by residents of the residential subdivisions covered by this Ordinance subject to the rules and regulations of the HOA concerned; and

4. Other vehicles as may be determined by the Office of the City Mayor thru the recommendation by the BTMD, and the affected HOA.

**WHEREAS**, Municipal Trial Court and Regional Trial Court judges assigned at the City of Bacoor, Cavite need to take extra precautions in order to ensure their safety and having unhindered access to the Solidarity Route will not only help them beat traffic but will also lessen their exposure to unnecessary safety risks.

**WHEREAS**, in view of their unique situation and the valuable role they play in the administration of justice, the Sangguniang Panlungsod unanimously decided to exempt Municipal Trial Court and Regional Trial Court judges assigned at the City of Bacoor, Cavite from complying with the various requirements of City Ordinance No. 255-2023 and shall be entitled to get a Solidarity Route sticker for the cars they use in going to work.

**NOW THEREFORE**, upon motion of Hon. Roberto L. Advincula duly seconded by the rest of the council **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to exempt municipal trial court and regional trial court judges assigned at the City of Bacoor, Cavite from complying with the various requirements of City Ordinance No. 255-2023 and shall be entitled to get a Solidarity Route sticker for the cars they use in going to work.

**RESOLVED FURTHER** that copies of this Resolution shall be posted the bulletin boards of all barangays in the City and shall be furnished to the President of all homeowners associations in the City of Bacoor, Cavite.

**RESOLVED LASTLY**, that copies of this Resolution shall be transmitted to the Clerk of Court of all trial courts within the City of Bacoor, Cavite, the Bacoor Traffic and Management Department (BTMD), the Bacoor Police Chief, to the Office of the City Mayor, to the University of the Philippines-Office of the National Administrative Registry (UP-ONAR) and to all government agencies/offices concerned.
