WHEREAS, on 6 October 2023, the Office of the Sangguniang Panlungsod received an endorsement letter from the Office of the City Mayor requesting to pass a resolution authorizing the City Mayor to sign the Deed of Donation and Acceptance on behalf of the City Government of Bacoor with the Department of Health Center for Health Development IV-A relative to the donation of medical equipment to the Bacoor City Super Health Center.

WHEREAS, the **Health Facility Enhancement Program (HFEP)** of the of the Department of Health (DOH) was funded under General Appropriations Act (GAA) 2022 like the procurement of medical equipment to be distributed to the project sites/ and DOH hospitals/offices, Super Health Centers (SHCs), City Health Offices, Rural Health Units, and Barangay Health Stations in order to facilitate the project implementation.

WHEREAS, the City Government of Bacoor, Province of Cavite is one of the recipients of a Portable X-ray Machine 300 MAh (Analog) that was included in **Health Facility Enhancement Program (HFEP)** of the Department of Health (DOH) funding under the GAA 2022 for Bacoor City Super Health Centers.
