A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-309 ENTITLED: "A RESOLUTION AMENDING CITY RESOLUTION NO. 2023-286 ENTITLED: 'A RESOLUTION AUTHORIZING THE PURCHASE OF FIVE MOTOR VEHICLES BY THE GENERAL SERVICES OFFICE (GSO) IN SUPPORT OF THE PEACE AND ORDER/ PUBLIC SAFETY PROGRAM OF THE LOCAL GOVERNMENT OF THE CITY OF BACOOR, CAVITE' REGARDING CHANGES IN THE SPECIFICATION OF THE FOUR (4) MULTIPURPOSE VEHICLES" IN ORDER TO MAXIMIZE THE APPROVED BUDGET OF PHP6,000,000.00 FOR THE SAID CONTRACT AND TO AUTHORIZE THE PURCHASE AN ADDITIONAL OF ONE (1) MOTOR VEHICLE'.

WHEREAS, on 26 September 2023, the Office of the Sangguniang Panlungsod received a request from the Office of the City Mayor, seeking the amendment of City Resolution No. 2023-309 which amended City Resolution No. 2023-286 authorizing the purchase of five (5) motor vehicles by the General Services Office (GSO), with the aim of reinforcing the Peace and Order/Public Safety program, particularly pertaining to the changes of specification of the four (4) multipurpose vehicles and removing the one (1) service vehicle that will be change into six (6) multipurpose vehicles.

WHEREAS, City Resolution No. 2023-309 earmarked a budget of Four Million Three Hundred Thirty Seven Thousand One Hundred and Sixty pesos (Php 4,337,160.00) for the changes of specification of the four (4) multipurpose vehicles.

WHEREAS, in adherence to the Department of Interior and Local Government (DILG) Memorandum Circular No. 2022-105, it was discovered that the actual cost of Six (6)

WHEREAS, the amendment of the number of vehicles and the accompanying budget adjustment is pivotal to ensuring that the multipurpose vehicles procured align with the stipulated standards and serve their to be intended functions in promoting peace and order as well a public safety in the City of Bacoor.

WHEREAS, it remains the fiduciary duty of the City Government of Bacoor, under its charter and prevailing statutes, to judiciously utilize public funds and ensure the efficient execution of its projects and programs for the greater welfare of its residents.

NOW THEREFORE, upon motion of Hon. Rogelio M. Nolasco, unanimously seconded by the rest of the body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to amend City Resolution No. 2023-309 by stating that the total number of motor vehicles to be purchase by the GSO would be six (6) multi-purpose vehicles and have a worth of Php 5,684,550.00 and not the five (5) multi-purpose vehicles worth Php 4,337,160.00 as erroneously stated in the said Resolution.

RESOLVE LASTLY, to furnish the DILG, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this Resolution.
