A RESOLUTION INTERPOSING NO OBJECTION TO THE INTENT OF METROPOLITAN GAMING AND TRADING CORPORATION TO OPERATE ELECTRONIC BINGO, E-GAMES AND OTHER PAGCOR GAMING ACTIVITIES, PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) LOTTERY AND PCSO GAMING ACTIVITIES AT VARIOUS LOCATIONS IN THE CITY OF BACCOOR, CAVITE.

WHEREAS, Section 447, (3) of Republic Act. No. 7160 (otherwise known as the "Local Government Code of 1991") grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality and to regulate any business, occupation, or practice of profession or calling which does not require government examination within the municipality and the conditions under which the license for said business or practice of profession may be issued or revoked.

WHEREAS, Metropolitan Gaming and Trading Corporation ("Metropolitan") is a domestic corporation duly organized and existing under and by virtue of Philippine laws.

WHEREAS, Metropolitan intends to operate an electronic bingo, E-games, and other gaming activities, Philippine Charity Sweepstakes Office (PCSO) Lottery and PCSO gaming activities approved by the Philippine Amusement Gaming Corporation (PAGCOR) situated at the following sites in the City of Bacoor, Cavite:

1. New City Hub Building, Tirona Highway, Barangay Habay I Bacoor City, Cavite;
2. Ocampo Building, Barangay Zapote IV, Bacoor City, Cavite;
3. Revilla Business Park, Barangay. Habay 2, Bacoor City, Cavite;

WHEREAS, after a thorough deliberation on the said matter, majority of the members of the 5th Sangguniang Panlungsod of Bacoor City, Cavite decided not to pose any objection to the granting of a business permit by the City Mayor to Metropolitan to allow the latter to operate an electronic bingo, e-games, and other gaming activities, PCSO Lottery and PCSO gaming activities approved by the PAGCOR within the City of Bacoor, Cavite subject, however, to the strict compliance of the said Corporation to certain conditions hereinafter set forth.

NOW, THEREFORE, upon motion of Councilor Michael E. Solis unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod not to pose any objection to the granting of a business permit by the City Mayor to the Corporation for the latter's operation of an electronic bingo, e-games and other gaming activities, PCSO Lottery and PCSO gaming activities approved by the PAGCOR at the sites mentioned above within the City of Bacoor, Cavite provided that the said Corporation will strictly comply with the following conditions, to wit:

- a) the said business permit shall be effective for only one (1) year, which period shall be reckoned from the date of issuance of such business permit;
- b) Metropolitan shall not allow any minor, or any student in uniform irrespective of age, from entering, loitering, or playing bingo or other games of chance within the premises of the bingo hall/s that it intends to operate within the City of Bacoor, Cavite;
- c) the said business permit shall be limited within the City Bacoor, Cavite;
- d) Metropolitan must first obtain a Fire Inspection Safety Clearance from the Office of the Fire Marshall of Bacoor, Cavite before the said business permit can be issued;
- e) Metropolitan must submit its Certificate of Incorporation, Articles of Incorporation and By-laws as duly issued and/or approved by the securities and Exchange Commission (SEC) with the Business Permit and Licensing Department (BPLD) of the city government before a business permit can be issued to the Corporation;
- f) Metropolitan must submit to the BPLD and to the Office of the Secretary of the Sangguniang Panlungsod a certified true copy of its PAGCOR franchise.
- g) Metropolitan must pay any and all pending liabilities and taxes, which may include penalties or fines imposed against Metropolitan by past municipal administrations, that it still owe the city

h) Metropolitan shall be required to pay the city government a city business tax equivalent to one percent (1%) of its gross revenues to the City Treasurer.
