A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT IV-A (DOH-CHDIVA) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR REGARDING THE DONATION OF SEVERAL DENTAL SURGICAL INSTRUMENTS AND OTHER ORAL HEALTH COMMODITIES.

WHEREAS, on 18 October 2023, the Office of the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting that a resolution be passed authorizing the City Mayor, Hon. Strike B. Revilla, to sign a Deed of Donation and Acceptance between the City Government of Bacoor and the Department of Health Center for Health Development (**DOH-CHD**) IVA.

WHEREAS, the Government of the Philippines, through the Department of Health, is a recipient of a grant from the Health Facility Enhancement Program (HFEP) budget, subject to the General Appropriation Act (GAA), to contribute to the improvement of the health of the population, especially the poor and most vulnerable, and the attainment of health-related Millennium Development Goals (MDGs), through a more effective, efficient, and equitable system.

WHEREAS, the DOH-CHD IVA intends to donate several dental surgical instruments and other oral health commodities to the City Government of Bacoor particularly described as follows:

1. Three (3) kits of Pit and Fissure Sealant (PFS)
2. One (1) piece of Health Education Dental Model
3. One (1) set of Pediatric Dental Instrument
4. One (1) piece of Aqueous Silver Diamene F2
