WHEREAS, Shapel Homes Incorporated is the registered owner of a parcel of land as described under Transfer Certificate of Title No. T-280964 located at Perpetual Village 7, Barangay Mambog 5, Bacoor City, Cavite with an area of Eight Hundred Fifty One (851) square meters, more or less;

NOW, THEREFORE, after careful deliberation, upon motion of Councilor Alde Joselito F. Pagulayan duly seconded by the rest of the Body in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Strike B. Revilla, to sign a Deed of Donation between the City Government of Bacoor and Shapel Homes Incorporated regarding the donation of open space situated within Parkdale I, Perpetual Village 7, Barangay Mambog 5, Bacoor City, Cavite. **PROVIDED**, that the said Deed of Donation must state that the various real property taxes owed by the donor to the City Government of Bacoor shall be paid by the donor.
