WHEREAS, Section 3 of Republic Act No. 7160 (the "Local Government Code of 1991") provides that local government units may group themselves, consolidate or coordinate their efforts, services, and resources for purposes commonly beneficial to them.

WHEREAS, on 28 November 2016, the Sangguniang Panlungsod passed City Resolution No. 2016-147 authorizing the former City Mayor, the Honorable Lani Mercado-Revilla, to pass a resolution authorizing her to sign a Sister City Agreement with the City of Manila.

WHEREAS, a Sister City Agreement between the City of Manila and the City of Bacoor was signed by former Mayor Joseph Estrada of Manila and former Mayor Mercado-Revilla because of the said Resolution.

WHEREAS, the Office of the City Mayor requested the Sangguniang Panlungsod for authority to reaffirm the said Agreement in order to further strengthen the legal ties that bind the sister cities of Manila and Bacoor.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica, unanimously seconded by the rest of the Council in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to authorize the City Mayor, Hon. Strike B.
