WHEREAS, in compliance with Memorandum Circular No. 2022-105, dated 25 August 2022 issued by the Department of the Interior and Local Government (DILG), entitled: "The Revised Policy Guidelines on Motor Vehicles Purchase/Acquisition, Used and Rental by the Local Government Units", the General Services Office requested the Sangguniang Panlungsod to authorize the purchase of two (2) amphibious trucks by way of a resolution as described below:
