A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY AT BARANGAY TALABA 2, CITY OF BACOOR, CAVITE AND AUTHORIZING THE RELEASE OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in a residential unit at Sitio Lati in Barangay Talaba 2 in the early morning of 15 December 2023, that rapidly spread to adjacent residential units which were mostly made from light materials thereby affecting around 100 families whose houses were destroyed.

WHEREAS, the Bacoor City Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 4, Series of 2023 dated December 15, 2023, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Talaba 2, City of Bacoor, Cavite and authorizing the release of **Five Million Pesos (Php 5,000,000.00)** from the City Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRRMC Resolution No. 4, Series of 2023 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.
