A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE TRIPARTITE MEMORANDUM OF AGREEMENT AMONG THE CITY GOVERNMENT OF BACOR, THE BUREAU OF FIRE PROTECTION (BFP) BACOR CITY AND THE DEPARTMENT OF EDUCATION (DepEd) BACOR CITY REGARDING THE IMPLEMENTATION OF SCHOOL-BASED RESPONSE (SBR) TRAINING FOR BACOR PUBLIC SCHOOL TEACHERS AND STUDENTS.

WHEREAS, the 1987 Constitution of the Philippines, particularly Section 5, Article II, enshrines the principle that peace and order, as well as the promotion of the general welfare, are essential for the enjoyment and sustenance of a democratic society.

WHEREAS, in line with this constitutional principle, City Ordinance No. 248-2022 mandates that all students, parent-teacher association members, employees of businesses, tricycle drivers and operators, and public officials and employees in Bacoor undergo emergency response training as part of the city's Disaster Preparedness Program.

WHEREAS, recognizing the critical importance of emergency preparedness, the Bureau of Fire Protection, the Department of Education - City Schools Division of Bacoor, and the City Government of Bacoor have collaboratively identified the need to execute a Memorandum of Agreement for the conduct of school-based response training specifically targeted at Bacoor public school teachers and students. The proposed Memorandum of Agreement is attached and made an integral part of this Resolution.

WHEREAS, the implementation of such response training in schools offers multiple benefits, including but not limited to enhancing the readiness of teachers and students in facing emergencies, fostering a culture of safety and preparedness within the school community, and ensuring a swift and coordinated response in times of crisis.

WHEREAS, the benefits of holding response training in schools extend beyond the immediate safety of the school environment, contributing significantly to the resilience and preparedness of the broader Bacoor community in the face of disasters and emergencies.

WHEREAS, the City Mayor, Hon. Strike B. Revilla, is empowered to represent the City of Bacoor in its business transactions and to sign on its behalf all contracts, upon the authority of the Sangguniang Panlungsod, as stipulated under Republic Act No. 7160, also known as the Local Government Code of 1991.

NOW THEREFORE, upon motion of Hon. Alde Joselito F. Pagulayan, unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor, Hon. Strike B. Revilla, to sign the proposed tripartite Memorandum of Agreement among the City Government of Bacoor, the Bureau of Fire Protection (BFP) Bacoor City and the Department of Education (DepEd) City Schools Division of Bacoor City regarding the implementation of School-Based Response (SBR) training for Bacoor public school teachers and students.
