A RESOLUTION AUTHORIZING THE CITY TREASURER TO OPEN A TRUST FUND ACCOUNT WITH THE LAND BANK OF THE PHILIPPINES WHERE FUNDS FROM THE DEPARTMENT OF TRANSPORTATION FOR THE ESTABLISHMENT OF ACTIVE TRANSPORT INFRASTRUCTURE IN THE CITY OF BACOR, CAVITE WILL BE DOWNLOADED.

WHEREAS, the Department of Transportation, in coordination and cooperation with the City of Bacoor, is committed to establishing active transport infrastructure as an environmentally sustainable alternative to motorized vehicles for the benefit of commuters.

WHEREAS, a key component of this initiative is the construction of a bike lane within the City of Bacoor to promote active transportation and enhance traffic flow.

WHEREAS, in support of this endeavor, the Department of Transportation has requested the opening of a trust fund account at the Land Bank of the Philippines, enabling the efficient transfer and management of funds allocated for this project.

WHEREAS, on 26 October 2023, the Sangguniang Panlungsod received a communication from the Office of the City Administrator, requesting the passage of a resolution to authorize the City Treasurer to open the said trust fund account.

WHEREAS, the promotion of active transportation is vital for traffic management in Bacoor, as it presents a viable solution to reduce congestion and improve the mobility of residents.

WHEREAS, the adoption of active transportation methods, such as cycling and walking, contributes significantly to environmental preservation by reducing carbon emissions and enhancing air quality.
