A RESOLUTION APPROVING THE POSITION PAPER IN SUPPORT OF THE MERGER OF VARIOUS BARANGAY IN THE CITY OF BACOR, CAVITE AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE SAME ON BEHALF OF THE CITY OF BACOR.

WHEREAS, the City of Bacoor, governed by the mandates of Republic Act No. 10160, is committed to enhancing the governance and administrative efficiency of its barangays for the benefit of its constituents.

WHEREAS, the barangay is recognized as the most fundamental political unit, entrusted with the planning and implementation of government policies, plans, programs, projects, and activities that significantly impact the lives of the community.

WHEREAS, Republic Act No. 10160 as amended by Republic Act No. 11274, listed seventy-three (73) barangays in the City of Bacoor. A substantial number of barangays in the City of Bacoor were operating with incomes below PHP 10,000,000.00, which limited their capacity to deliver basic services effectively to their respective constituencies.

WHEREAS, the Sangguniang Panlungsod of Bacoor passed City Ordinance No. 273-2023, or the Barangay Merger and Reorganization Ordinance, to address these challenges and improve service delivery. City Ordinance No. 273-2023 provided for the merger of several barangays in the City of Bacoor so that the total number of barangays would be reduced, making it so that each barangay had a larger budget.

WHEREAS, on 29 July 2023, the Commission on Elections conducted a plebiscite, wherein 90.44% of the participating voters supported the merging and renaming of various barangays, demonstrating the community's overwhelming approval of this initiative.

WHEREAS, the merger of barangays is expected to yield significant benefits including cost savings in general administration, enhancement in the delivery of diverse and better-quality services, and improved management of spillover effects in neighboring areas.

WHEREAS, the amalgamation aligns with the City Government's duty under Republic Act No. 10160 to ensure

WHEREAS, House Bill No. 9272, introduced by Representatives Lani Mercado-Revilla, Bryan B. Revilla, and Ramon Jolo B. Revilla III, seeks to amend Republic Act No. 10160 to reflect the results of the merger.

WHEREAS, on 9 November 2023, the City Government of Bacoor received a letter from the Committee on Local Government in the House of Representatives. The letter invited the City of Bacoor to attend the Committee hearing to be held on 14 November 2023 regarding House Bill No. 9272. The same letter also requested the City of Bacoor to provide a position paper relating to the rationale behind the merger.

WHEREAS, the Office of the City Legal Services of the City of Bacoor drafted a proposed position paper. The position paper articulating the rationale and expected outcomes of the barangay merger reflects a thorough and insightful analysis, emphasizing the importance of this restructuring for the overall progress of the city.

WHEREAS, the Sangguniang Panlungsod was requested to issue a resolution authorizing the City Mayor of the City of Bacoor, Hon. Strike B. Revilla, to approve and sign the position paper.

NOW THEREFORE, upon unanimous motion of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the position paper in support of the merger of various barangays in the City of Bacoor, Cavite and to authorize the City Mayor, Hon. Strike B. Revilla to sign the same on behalf of the City of Bacoor.

RESOLVED LASTLY, to furnish the University of the Philippines-Office of the National Administrative Register (UP-ONAR), and other government agencies concerned with copies of this Resolution.
