A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT (SISTERHOOD AGREEMENT) BETWEEN THE CITY GOVERNMENT OF BACOR AND THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL.

WHEREAS, Section 3 of Republic Act No. 7160 (the "Local Government Code of 1991") provides that local government units may group themselves, consolidate or coordinate their efforts, services, and resources for purposes commonly beneficial to them.

WHEREAS, on 12 October 2023, the Sangguniang Panlungsod received a request from the Office of the City Mayor for authority to sign a Memorandum of Agreement between the City of Bacoor and the Municipality of Lupon, Davao Oriental. The request informed the Sangguniang Panlungsod that the Municipality of Lupon, Davao Oriental has expressed interest in entering a Sisterhood Agreement with the City of Bacoor. Said Sisterhood Agreement is embodied in the proposed Memorandum of Agreement.

The proposed Memorandum of Agreement is incorporated and made an integral part of this Resolution.

WHEREAS, under the proposed Memorandum of Agreement, the City of Bacoor and the Municipality of Lupon, Davao Oriental mutually agree to authorize official visits, promote economic cooperation, commerce, and investment. Adopt a faculty and student exchange program, adopt an expert exchange program to facilitate technical capacity-building. Adopt cross visit, study tours or "Lakbay-Aral" and other exchange visit. Both LGUs agree to entertain additional project proposals as long as they are able to be funded and meet the criteria of offering mutual benefit and promoting people-to-people relation

Both LGUs agree to initiate program and projects that would promote local development. Each LGU agrees to shoulder all the expenses or funding necessary to execute the projects it has introduced or proposed to the other LGU.

NOW THEREFORE, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by the rest of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite to authorize the City Mayor to sign the proposed Memorandum of Agreement between the City Government of Bacoor and the Municipality of Lupon, Davao Oriental relating to the forging of a sisterhood relationship between both local government units.

RESOLVE LASTLY, to furnish the DILG, the Office of the Municipal Mayor of the municipal of Lupon, Davao Oriental, and the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this Resolution.
