A RESOLUTION REVOKING CITY RESOLUTION NO. 2023-259 DUE TO THE FAILURE OF ICON CONSTRUCTION AND BUILDERS CORPORATION TO FULFILL ITS CONTRACTUAL OBLIGATIONS IN RELATION TO THE CITY GOVERNMENT'S PUBLIC HOUSING PROGRAM PURSUANT TO CITY OF BACOOR URBAN DEVELOPMENT AND HOUSING BOARD RESOLUTION NO. 12, SERIES OF 2023.

**WHEREAS**, on 02 January 2024, Hon. Catherine Sarino-Evaristo, the Acting City Mayor, requested the Sangguniang Panlungsod to pass a resolution revoking City Resolution No. 2023-259 which was issued by the City Council on 22 May 2023 which authorized the City Mayor, Hon. Strike B. Revilla, to sign a Memorandum of Agreement with ICON Construction and Builder's Corporation in relation to the implementation of the "Pambansang Pabahay Para sa Pilipino: Zero ISF Program for 2028" by the Department of Human Settlements and Urban Development (DHSUD) in Bacoor City, Cavite for alleged breach of the said contract.

**WHEREAS**, on 10 July 2023, the City Mayor on behalf of the City Government of Bacoor by virtue of the abovementioned resolution entered into an agreement with ICON Construction and Builder's Corporation for the construction and development of a housing project.

**WHEREAS**, on 12 December 2023, the City of Bacoor Urban Development and Housing Board (CBUDHB) issued a resolution endorsing to the Sangguniang Panlungsod the approval of authority of the Honorable City Mayor and Chairman of the CBUDHB to terminate the Memorandum of Agreement between the City Government of Bacoor and ICON Construction and Builder's Corporation relative to the housing projects in the city which was made and entered on 10 July 2023;

**WHEREAS**, after deliberating upon the said request, the Sangguniang Panlungsod unanimously decided to grant the request of the Acting City Mayor, Hon. Catherine Sarino-Evaristo.
