**A RESOLUTION APPROVING: (A) THE CREATION OF THE BARANGAY TRANSITION AND STABILIZATION TRUST FUND, (B) THE TRANSFER/DIVERSION OF ALL UNEXPENDED FUNDS OF THE DEFUNCT BARANGAYS OF THE CITY OF BACOR, CAVITE AFFECTED BY THE RATIFICATION OF CITY ORDINANCE NO. 275-2023 DURING THE PLEBISCITE HELD ON 29 JULY 2023 TO THE NEWLY CREATED AND/OR RENAMED BARANGAYS OF THE CITY, (C) AUTHORIZING THE NEWLY CREATED AND/OR RENAMED BARANGAYS OF THE CITY TO RECEIVE THE TRUST FUNDS OF THE SAID DEFUNCT BARANGAYS, (D) CONFIRMING THE AUTHORIZED SIGNATORIES OF THE SAID NEWLY CREATED AND/OR RENAMED BARANGAYS IN THEIR RESPECTIVE BANK ACCOUNTS, (E) THE CLOSURE OF THE BANK ACCOUNTS OF THE SAID DEFUNCT BARANGAYS AND THE TRANSFER OF ANY FUNDS CONTAINED THEREIN TO THE BANK ACCOUNTS OF THE NEWLY CREATED AND/OR RENAMED BARANGAYS, (F) CANCELLATION OF THE TAX IDENTIFICATION NUMBER (TIN) OF THE DEFUNCT BARANGAYS OF THE CITY, (G) THE INTERNAL RULES OF PROCEDURES OF ALL SANGGUNIANG BARANGAY AND SANGGUNIANG KABATAAN OF THE CITY OF BACOR, AND (H) THE REQUEST OF THE OFFICIALS OF THE NEWLY-CREATED BARANGAYS OF THE CITY TO PETITION THE DEPARTMENT OF BUDGET AND MANAGEMENT TO ADJUST THEIR RESPECTIVE NATIONAL TAX ALLOTMENTS DUE TO THE SAID MERGER OF BARANGAYS.**

**WHEREAS**, on 29 July 2023, City Ordinance No. 275-2023 (entitled: "AN ORDINANCE MERGING VARIOUS BARANGAYS IN THE CITY OF BACOR, CAVITE TO ENSURE THEIR ECONOMIC GROWTH AND DEVELOPMENT, RENAMING THE MERGED BARANGAYS AND THE BARANGAYS AFFECTED BY SUCH MERGER, FIXING THEIR RESPECTIVE TERRITORIAL BOUNDARIES, AND APPROPRIATING FUNDS FOR THE HOLDING OF A PLEBISCITE FOR THE APPROVAL HEREOF AS MANDATED BY LAW.") was overwhelmingly ratified by the Bacoor City electorate in a plebiscite called for the said purpose which was supervised by the Commission on Elections.

**WHEREAS**, Section 7 and 8 of the said Ordinance provides that:

**"Section 7. Assets and Barangay Hall.** The physical assets of the merged barangays such as but not limited to buildings,

vehicles, office equipment and supplies, and furniture shall become part of the physical assets of the new barangay pursuant to relevant government regulations. The General Services Officer and the City Accountant of the Bacoor City Government are hereby empowered and directed to assist the affected barangays in the implementation of this provision. After the October 2023 barangay elections, the officials of the newly created barangays shall determine the location of their barangay hall. The funds of the various barangays that have been merged pursuant to this Ordinance shall become part of the funds of the new barangays herein created.

**Section 8. Income and Funds.** The income and funds of the merged barangays shall be transferred to the new barangays mentioned in Section 2 hereof pursuant to relevant government regulations. The City Budget Officer, the City Treasurer and the City Accountant of the Bacoor City Government are hereby empowered and directed to assist the affected barangays in the implementation of this provision."

**WHEREAS**, as a consequence of the said merger, the officials of the 18 newly created and five (5) renamed barangays of the City of Bacoor passed various barangay resolutions requesting the Sangguniang Panlungsod to approve the following matters, to wit:

- (a) the creation of the Barangay Transition and Stabilization Trust Fund which will enable the officials of the said barangays to pay for unpaid utility bills of their barangay;
- (b) the transfer/diversion of all unexpended funds of the defunct barangays of the City of Bacoor, Cavite that were affected by the ratification of City Ordinance No. 275-2023 during the plebiscite held on 29 July 2023 to the newly created barangays of the city;
- (c) authorizing the newly created and/or renamed barangays of the City to receive the trust funds of the said defunct barangays;
- (d) confirming the authorized signatories of the said newly created and/or renamed barangays in their respective bank accounts;
- (e) the closure of the bank accounts of the said defunct barangays and the transfer of any funds contained therein to the bank accounts of the newly created and/or renamed barangays;
- (f) cancellation of the tax identification number (TIN) of the defunct barangays of the city;
- (g) the internal rules of procedures of all Sangguniang Barangay and Sangguniang Kabataan of the City of Bacoor; and
- (h) the request of the officials of the newly created and renamed barangays of the city to petition the Department of Budget and Management (DBM) to adjust their respective national tax allotments due to the said merger of barangays.
