A RESOLUTION SUPPORTING THE APPROVAL OF PROPOSED AMENDMENTS TO REPUBLIC ACT NO. 6975 (THE "DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT ACT OF 1990") AS AMENDED AND REPUBLIC ACT NO. 8551 (THE "PHILIPPINE NATIONAL POLICE REFORM AND REORGANIZATION ACT 1998") BY THE CONGRESS OF THE PHILIPPINES.

WHEREAS, on 5 December 2023, the City Mayor, Hon. Strike B. Revilla, wrote the Sangguniang Panlungsod and forwarded the request of the Chief of Police of the City of Bacoor, Cavite, Lt. Col. John Paolo V. Carracedo, for a "manifesto in support of the shepherding of PNP priority legislative measures for the 19th Congress".

WHEREAS, upon review of the documents attached to the said letter, it dawned upon the members of the City Council that Lt. Col. Carracedo is actually requesting for the passage of a city resolution supporting the approval of proposed amendments to Republic Act No. 6975 as amended (the "Department of Interior and Local Government Act of 1990") and to Republic Act No. 8551 (the "Philippine National Police Reform and Reorganization Act of 1998") now pending before the 19th Congress.

WHEREAS, a review of the bill furnished to the City Council revealed that the proposed changes to the said laws might lead to further improving the manner in which the PNP performs its task of maintaining peace and order in the country.

NOW THEREFORE, upon motion of Hon. Alejandro F. Gutierrez, duly seconded by the rest of the council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular session duly assembled to express its unqualified support for the approval of the various amendments being proposed by the Philippine National Police to RA 6975 as amended and to RA 8551, respectively.
