CITY RESOLUTION NO. 2024-420 Series of 2024

A RESOLUTION SUPPORTING AND ENDORSING THE APPROVAL BY CONGRESS OF HOUSE BILL NO. 8721 CREATING THE MARIANO NORIEL SENIOR HIGH SCHOOL AND HOUSE BILL NO. 8722 CREATING THE EDILBERTO EVANGELISTA SENIOR HIGH SCHOOL, RESPECTIVELY, AND AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN AND EXECUTE A USUFRUCT AGREEMENT WITH THE DEPARTMENT OF EDUCATION-BACOR ON THE SITE OF THE DULONG BAYAN SENIOR HIGH SCHOOL.

WHEREAS, Rep. Lani Mercado-Revilla of the 2nd District of the Province of Cavite, informed the City Mayor in writing that the location of the Dulong Bayan Senior High School is unregistered land while the site of the Camposanto Senior High School is registered under the name of the Philippine National Railways (PNR).

WHEREAS, Rep. Mercado-Revilla is the principal author of House Bill No. 8721 which shall establish the Edilberto Evangelista Senior High School and House Bill No. 8722 which shall establish the Mariano Noriel Senior High School. Both bills are now pending at the House of Representatives.

WHEREAS, Rep. Mercado-Revilla requests that the Sangguniang Panlungsod pass a Resolution supporting the said House Bills and authorizing the City Mayor to sign and execute a Usufruct Agreement with the Department of Education-Bacoor on the site of the Dulong Bayan Senior High School once the same has been deeded in favor of the City Government.

WHEREAS, the members of the Sangguniang Panlungsod conducted hearings on the said request and unanimously decided to pass the resolution mentioned above.

NOW THEREFORE, upon motion of Hon. Alde Joselito Pagulayan, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to support and endorse the approval of House Bill No. 8721 and House Bill No. 8722 by Congress and authorizing the City Mayor, Hon. Strike B. Revilla, to sign and execute a Usufruct Agreement in favor of the Department of Education-Bacoor involving the land on which the Dulong Bayan Senior High School is situated once the same has been deeded in favor of the City Government.




