WHEREAS, the intention of the said ordinance was to merge the **local governments of various barangays** in the City in accordance with Section 6, Chapter II of Republic Act No. 7160 (the "**Local Government Code of 1991**") by means of an ordinance and **not** to merge the senior citizens associations of the said barangays. However, the unintended consequence of the said merger is the confusion it caused among officials of various senior citizens associations in barangays that were merged with other barangays to make a new barangay with regard their respective organizational structures particularly, the term of office of the presidents of the said associations.

(SAPAGKAT, ang layunin ng nasabing ordinansa ay pagsamahin ang iba't-ibang mga barangay sa Lungsod alinsunod sa Seksyon 6, Kabanata II ng Batas Republika Blg. 7160 (ang "Local Government Code of 1991") sa pamamagitan ng isang ordinansa at hindi nabanggit na pagsamahin ang Asosasyon ng Senior Citizens ng mga nasabing barangay. WHEREAS, the Pederasyon ng Senior Citizens Associations ng Lungsod ng Bacoor, Cavite Inc. (the "Pederasyon"), took it upon itself to resolve the said issue by promulgating a proposed "**IMPLEMENTING RULES FOR THE DESIGNATION OF THE CHIEF BARANGAY SENIOR PRESIDENT WHO WILL REPRESENT THE BARANGAY ASSOCIATIONS AFFECTED BY THE MERGING OF TWO OR MORE BARANGAY ORGANIZATIONS INTO ONE**" (the "Implementing Rules") during its monthly general assembly held on 6 November 2023 through its Board Resolution No. 4. A copy of the said Board Resolution and Implementing Rules were sent to the Sangguniang Panlungsod for its review.

BARANGAY SENIOR PRESIDENT WHO WILL REPRESENT THE BARANGAY ASSOCIATIONS AFFECTED BY THE MERGING OF TWO OR MORE BARANGAY ORGANIZATIONS INTO ONE" (ang "Mga Panuntunan sa Pagpapatupad") sa buwanang pangkalahatang pagpupulong nito na ginanap noong ika-6 ng Nobyembre 2023 sa pamamagitan ng Board Resolution No. 4. Isang kopya ng nasabing Board Resolution at Implementing Rules ay ipinadala sa Sangguniang Panlungsod para sa pagsusuri nito.)

WHEREAS, the Pederasyon – like all the senior citizens associations in the City of Bacoor – are private organizations that are beyond the jurisdiction of the Sangguniang Panlungsod. However, Section 1 of Republic Act No. 7432 as amended by Republic Act No. 9994 provides that:

(SAPAGKAT, ang Pederasyon – tulad ng lahat ng asosasyon ng senior citizens sa Lungsod ng Bacoor – ay mga pribadong organisasyon na wala sa hurisdiksyon ng Sangguniang Panlungsod. Gayunpaman, ang Section 1 ng Republic Act No. 7432 na sinusugan ng Republic Act No. 9994 ay nagtatadhana na:

"SECTION 1. Declaration of Policies and Objectives. – As provided in the Constitution of the Republic of the Philippines, it is the declared policy of the State to promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living and an improved quality of life. In the Declaration of Principles and State Policies in Article II, Sections 10 and 11, it is further declared that the State shall provide social justice in all phases of national development and that the State values the dignity of every human person and guarantees full respect for human rights.

"SEKSYON 1. Deklarasyon ng Mga Patakaran at Layunin. – Gaya ng nakatala sa Konstitusyon ng Republika ng Pilipinas, ipinahayag na patakaran ng Estado na itaguyod ang isang makatarungan at daynamikong kaayusang panlipunan na magtitiyak sa kaunlaran, kalayaan ng bansa, at magpapalaya sa mga mamamayan mula sa kahirapan sa pamamagitan ng mga patakaran ng pagbibigay ng mga sapat na serbisyong panlipunan, nagtataguyod ng ganap na trabaho, tumataas na antas ng pamumuhay at isang mabuting kalidad ng buhay. Sa Deklarasyon ng mga Prinsipyo at Mga Patakaran ng Estado sa Artikulo II, Seksyon 10 at 11, higit pang idineklara na ang Estado ay dapat magkaloob ng katarungang panlipunan sa lahat ng yugto ng pambansang kaunlaran at na pinahalalagan ng Estado ang dignidad ng bawat tao at ginagarantiyahan ang buong paggalang sa mga karapatang pantao.

"Article XIII, Section 11 of the Constitution provides that the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make

essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged, sick, elderly, disabled, women and children. Article XV, Section 4 of the Constitution Further declares that it is the duty of the family to take care of its elderly members while the State may design programs of social security for them.

"Ang Artikulo XIII, Seksyon 11 ng Saligang Batas ay nagtatadhana na ang Estado ay dapat magpatibay ng isang pinagsama-sama at komprehensibong diskarte sa pagpapaunlad ng kalusugan na dapat magsikap na sa lahat ng pagkakataon ay mayroong mga mahahalagang produkto, kalusugan at iba pang serbisyong panlipunan sa lahat ng mga tao sa abot-kayang halaga. Dapat bigyang prayoridad ang mga pangangailangan ng mga mahihirap, maysakit, matatanda, may kapansanan, kababaihan at mga bata. Ang Artikulo XV, Seksyon 4 ng Saligang Batas ay nagpapahayag din na tungkulin ng pamilya na pangalagaan ang matatandang miyembro nito habang ang Estado ay maaaring magdisenyo ng mga programang panlipunang seguridad para sa kanila.

"Consistent with these constitutional principles, this Act shall serve the following objectives:

"Alinsunod sa mga prinsipyong ito sa konstitusyon, ang Batas na ito ay magsisilbi sa mga sumusunod na layunin:

"(a) To recognize the rights of senior citizens to take their proper place in society and make it a concern of the family, community, and government;

"(a) Upang kilalanin ang mga karapatan ng mga senior citizens na kumuha ng kanilang nararapat na lugar sa lipunan at isaalang-alang ng pamilya, komunidad, at pamahalaan;

"(b) To give full support to the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens are integral part of Philippine society;

"(b) Upang magbigay ng buong suporta sa pagpapabuti ng kabuuang kapakanan ng mga matatanda at ang kanilang buong partisipasyon sa lipunan, isinasaalang-alang na ang mga senior citizens ay mahalagang bahagi ng lipunang Pilipino;

"(c) To motivate and encourage the senior citizens to contribute to nation building;

"(c) Upang hikayatin ang mga senior citizens na magambag sa pagbuo ng bansa;

"(d) To encourage their families and the communities they live with to reaffirm the valued Filipino tradition of caring for the senior citizens;

"(d) Hikayatin ang kanilang mga pamilya at ang kanilang mga komunidad na kinabibilangan na muling pagtibayin ang

“(e) To provide a comprehensive health care and rehabilitation system for disabled senior citizens to foster their capacity to attain a more meaningful and productive ageing; and

WHEREAS, it behooves the Sangguniang Panlungsod to find ways to assist the Pederasyon and the senior citizens associations under it in any way that will promote the achievement of the objectives of the aforementioned law.

WHEREAS, on 3 February 2023, Ms. Nenita Reyes (the Federation President) and Atty. Venus De Castro (the Head of the Office of Senior Citizens Affairs) signed the “AGREED ELECTION GUIDELINES FOR SENIOR CITIZEN’S ASSOCIATIONS IN THE CITY OF BACOR” (“Agreed Election Guidelines”) which was attested by Hon. Simplicio Dominguez (Chairperson of the Committee on Senior Citizens) and Hon. Reynaldo D. Palabrica (Chairperson of the Committee on Rules, and Privileges, Laws and Ordinances). The said Agreed Election Guidelines was formulated and approved by Ms. Reyes and Atty. De Castro in order to facilitate the manner of electing/appointing the officers of senior citizens association of merged barangays in the City of Bacoor.

WHEREAS, the Agreed Election Guidelines provide the following rules:

- 1) Elective Officers:
 - a. President
 - b. Vice President
 - c. Fifteen (15) Board of Directors (BOD) ; and
 - d. Auditor – shall be elected among and by all the elected Directors (The President and Vice President may vote)
- 2) Appointive Officers:
 - a. Secretary
 - b. Treasurer
 - c. Business Manager
 - d. Press Relation Officer
 - e. Sergeant At Arms

The elected President shall appoint the enumerated appointive officers form the elected Board of Directors and shall require the concurrence of the majority of the elected Board of Directors.
- 3) Qualifications of Candidates:
 - a. Must be a member of the association for at least one (1) year
 - b. Must be a resident of the barangay with jurisdiction over the association for at least one (1) year
 - c. Punong Barangay and government employees are not qualified.
- 4) Term of Office:

Elected Officers shall serve a term of Three (3) years and can be reelected for another one terms or two consecutive terms only. (The present term will be counted from the time he/she was elected before the merging of barangays).
