REVILLA, TO SIGN A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY, REGION 4A (DICT 4A) REGARDING THE DONATION OF INFORMATION AND COMMUNICATIONS TECHNOLOGY DEVICES AND EQUIPMENT TO THE BACOR CITY COMPUTER AND TECH4ED CENTER.

WHEREAS, on 22 January 2024, the Office of the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor on behalf of the City Government of Bacoor, to sign a Deed of Donation and Acceptance with the Department of Information and Communications Technology Region 4A (DICT 4A) regarding the donation of Information and Communications Technology devices and equipment to the Bacoor City Computer and Tech4ed Center.

WHEREAS, the DICT is mandated to provide efficient and effective information and communications technology infrastructure for transparent and accountable governance and, in particular, support the speedy enforcement of rules and delivery of accessible public services to the people.

WHEREAS, the City Government of Bacoor established its Tech4Ed Center in 2009 at Bacoor Computer Center located at Barangay Sinbanali (formerly Barangay Alima), Bacoor City, Cavite.

WHEREAS, the DICT 4A-Regional Office – ICT Literacy and Competency Development Bureau (ILCDB) has the intention to assist Bacoor Computer and Tech4Ed Center in order to upgrade the Tech4Ed Center to Digital Transformation Center (DTC) Level 1.

WHEREAS, after a careful deliberation and consideration of the provisions of the Deed of Donation (DODA), the council found the same to be advantageous to the City Government of Bacoor. The proposed DODA is incorporated hereto and will be made an integral part of this Resolution.
