**CITY RESOLUTION NO. 2024-428

A RESOLUTION AUTHORIZING MS. SLANEY SUE REYES, ANTI RED TAPE ACT (ARTA) OFFICER, TO CLAIM THE CASH REFUND FROM MERALCO AMOUNTING TO ONE MILLION TWO HUNDRED SEVENTY-NINE THOUSAND FIVE HUNDRED FIFTEEN AND NINETY-SIX CENTAVOS (PHP 1,279,515.96) FROM CASH ADVANCES PAID BY THE CITY GOVERNMENT ON SEVERAL PROJECTS.

WHEREAS, on 22 January 2024, the Office of the Sangguniang Panlungsod received a request letter from the Office of the City Mayor for the issuance of a Resolution authorizing Ms. Slaney Sue Reyes, ARTA Officer, regarding the claims for cash refund amounting to One Million Two Hundred Seventy-Nine Thousand Five Hundred Fifteen and Ninety-Six Centavos (PHP 1,279,515.96) of the city government as per Cash Advance Agreement with the MERALCO .

WHEREAS, as provided under prevailing government rules and guidelines and as stipulated in the Cash Advance Agreement, the City of Bacoor would advance to MERALCO an amount in cash as consideration for projects to be done by MERALCO. The City Government of Bacoor is entitled to refund a portion of the said Cash Advance which shall be made annually at the rate of 75% of the gross distribution revenue derived from customers that tapped to the poles and facilities erected by the power utility.

WHEREAS, through a letter dated December 20, 2023, MERALCO informed the City Government that the cash advance refund requires that a representative must present to MERALCO's Branch Manager the following documents: (1) Accomplished Reply/Quit Claim Form; (2) Accomplished Applicant Information Sheet; (3) Supporting papers
