WHEREAS, a letter dated 25 January 2024 from the Office of the City Mayor was received by the Sangguniang Panlungsod, endorsing the letter from CSWD Nutrition Unit relative to the passing of a resolution integrating the Local Nutrition Action Plan (LNAP) 2023-2025 to the Local Development Plan of the City of Bacoor, Province of Cavite.

WHEREAS, Presidential Decree No. 491, or the "Nutrition Act of the Philippines", created the National Nutrition Council (NNC) under the Office of the President as the highest policy-making and coordinating body for nutrition. The NNC oversees the implementation of the hunger mitigation program, formulates national food and nutrition policies and strategies and coordinates planning, monitoring and evaluation of the national nutrition program.

WHEREAS, as mandated through Department of Interior and Local Government Memorandum Circular 2018-42, states that:
