A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, AND THE CITY ADMINISTRATOR, ATTY. AIMEE T. NERI, TO NEGOTIATE WITH GOVERNMENT FINANCIAL INSTITUTIONS FOR THE PLANNED BORROWING OF TWO BILLION FIVE HUNDRED MILLION PESOS (Php 2,500,000,000.00) BY THE CITY GOVERNMENT TO FINANCE VARIOUS PUBLIC PROJECTS FOR THE PROMOTION OF GENERAL WELFARE, IMPROVING THE ADMINISTRATION OF JUSTICE, AND THE LOCAL HOUSING PROGRAM.
