WHEREAS, a letter dated 10 January 2024 from the Office of the City Administrator was received by the Sangguniang Panlungsod, wherein it was requested that a resolution be passed by the City Council granting authority to City Mayor, Hon. Strike B. Revilla to sign a Data Processing Agreement between the City Government and QPax Traffic Systems, Inc.

Strike B. Revilla, to sign a Data Processing Agreement with QPax Traffic Systems, Inc.
