CITY RESOLUTION NO. 2024-454 Series of 2024

A RESOLUTION DIRECTING THE OFFICE OF THE CITY LEGAL SERVICES TO COMPEL OUTGOING SANGGUNIANG KABATAAN OFFICIALS OF THE BARANGAYS OF THE CITY OF BACOOR, CAVITE WHO FAILED TO CLOSE OR UPDATE THE BANK ACCOUNT/S OF THEIR RESPECTIVE BARANGAYS AS MANDATED BY LAW.

WHEREAS, Section 20 (a) of the SK Reform Act of 2015 (Republic Act [RA] No. 10742), provides that ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan (SK). The sangguniang barangay shall appropriate the SK funds in lump-sum, which shall be disbursed solely for youth development and empowerment purposes. Furthermore, Section 20 (b) of the same law provides that the SK shall have financial independence in its operations, disbursements, and encashment of their fund, income and expenditures.

WHEREAS, Section 3.2.2 of Joint Budget Circular No. 1, Series of 2019, dated 23 January 2019 ("GUIDELINES ON THE APPROPRIATION, RELEASE, PLANNING, AND BUDGETING PROCESS FOR THE SK FUNDS.") issued by the Department of Budget and Management (DBM), the Department of Interior and Local Government (DILG), and the National Youth Commission (NYC) provides that: "Consistent with Section 20 (b) of RA No. 10742, the SK shall open a current account in the name of the SK in a bank, preferably government-owned, situated in or nearest to its area of jurisdiction, with the SK chairperson and the SK treasurer as the official signatories. For efficiency and economy purposes, it is strongly encouraged for the SK to open and maintain a depository account in the same bank and branch of its barangay. In the opening of account, the provisions of Department of Finance Department Circular No. 1-2017 dated May 11, 2017 shall be strictly observed.
