A RESOLUTION CONFIRMING THE ASSUMPTION OF HON. RANDY C. FRANCISCO AND HON. PALM ANGEL S. BUNCIO AS CHAIRPERSONS, VICE-CHAIRPERSONS, AND MEMBERS OF VARIOUS STANDING COMMITTEES OF THE 5TH SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOR, CAVITE.

WHEREAS, the Local Government Code of 1991 mandates the Sangguniang Panlungsod to approve its Internal Rules of Procedure and the composition of standing committees.

WHEREAS, on 14 November 2023, the Department of the Interior and Local Government (DILG)-Bacoor City conducted an election among the Sangguniang Kabataan (SK) Presidents of 47 barangays to represent the SK Federation President in the City of Bacoor. Hon. Palm Angel S. Buncio got the highest number of votes thus she became SK Federation President.

WHEREAS, on 15 December 2023, the Liga ng Barangay (LnB) conducted an election for the officers of the Liga ng Barangay of the City of Bacoor. Hon. Rafael Paterno III was elected as LnB President while Hon. Randy C. Francisco as LnB Vice President respectively.

WHEREAS, on 15 January 2024, Hon. Paterno won as Liga ng Barangay Provincial Chapter President and thus automatically became a member of the Sangguniang Panlalawigan.

WHEREAS, on 22 January 2024, Hon. Randy C. Francisco automatically assumed the position of the ex-officio representative of the LnB to the 5th Sangguniang Panlungsod of the City of Bacoor pursuant to the By-laws of the Liga ng Barangay National Chapter in view of the elevation of Hon. Paterno as LnB Provincial Chapter President.
