A RESOLUTION DIRECTING THE OFFICE OF THE CITY LEGAL SERVICE TO SEND A LETTER ADDRESSED TO THE OFFICERS OF THE HOMEOWNERS ASSOCIATION OF TOWN AND COUNTRY WEST SUBDIVISION REQUESTING THEM TO FURNISH THE CITY COUNCIL A COPY OF THEIR BOARD RESOLUTION ON THE LEGAL BASIS OF THE "NO HELMET POLICY" ALLEGEDLY BEING IMPLEMENTED BY THE SAID RESIDENTIAL SUBDIVISION.

WHEREAS, on 1 April 2024, Hon. Alde Joselito Pagulayan delivered a privilege speech and reported to the members of the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite that he saw a huge sign displayed at the gates of Town and Country West Subdivision in Barangay Molino 3 of this City directing motorcycle riders to remove their helmets while inside the said subdivision.

WHEREAS, Hon. Pagulayan reminded the City Council that if the said directive is actually being implemented, the same is a clear violation of Section 3 of Republic Act No. 10054 (the "Motorcycle Helmet Act of 2009") which provides that:

"Section 3. Mandatory Use of Motorcycle Helmets. - All motorcycle riders, including drivers and back riders, shall at all times wear standard protective motorcycle helmets while driving, whether long or short drives, in any type of road and highway."

Alde Joselito Pagulayan, unanimously approved by the rest of the City Council, **RESOLVES** as it is hereby **RESOLVED** to direct the Office of the City Legal Service of the City of Bacoor, Cavite to immediately write the officers of the homeowners association of Town and Country West Subdivision in Barangay Molino 3, City of Bacoor, Cavite and inquire if they are in fact implementing a "NO HELMET POLICY" within the said gated community, request for the legal basis of the said policy, and secure a copy of the Board Resolution, if any, issued by the HOA with regard the said policy.

RESOLVED LASTLY, to furnish the Office of the City Legal Service and the homeowners association of Town and Country West Subdivision with copies of this Resolution.
