CITY RESOLUTION NO. 2024-472

A RESOLUTION DIRECTING THE CITY HEALTH OFFICE AND ALL BARANGAY OFFICIALS OF THE CITY TO ACTIVELY ADVISE MEMBERS OF THE PUBLIC WHO ARE EXHIBITING SYMPTOMS OF RESPIRATORY DISEASES INCLUDING CHILDREN, PREGNANT OR NURSING WOMEN, SENIOR CITIZENS, AND THE INFIRM TO WEAR FACE MASKS WHILE IN PUBLIC TO PREVENT THE SPREAD OF PERTUSSIS AND/OR TO MINIMIZE ITS DELETERIOUS EFFECTS ON PUBLIC HEALTH.

WHEREAS, the painful memories created by the COVID-19 pandemic have barely receded from the minds of Bacooreños but they are again confronted by another potentially lethal public health issue.

WHEREAS, various local governments in the Province of Cavite and elsewhere in the country have declared the existence of a state of calamity due to the outbreak of numerous cases of pertussis within their respective territorial jurisdiction.

WHEREAS, the Department of Health reported that the said disease may be fatal if left untreated and advised the public that children, pregnant women, the old, and the infirm should avoid being exposed to it.

WHEREAS, because pertussis is an airborne disease, the possibility that it will infect residents of the City of Bacoor is

RESOLVED LASTLY, to furnish the DOH, the CHO, the Punong Barangay of all barangays of the City of Bacoor, and the University of the Philippines-Office of the National Administrative Register (UP-ONAR) with copies of this Resolution.
