A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN JOB ORDER CONTRACT OF PERSONNEL WHO WILL WORK AT THE LIGHT RAIL TRANSIT (LRT) LINE 1 SOUTH (CAVITE) EXTENSION PROJECT AND RATIFYING THE VARIOUS JOB ORDER CONTRACTS THAT THE CITY MAYOR ALREADY SIGNED IN RELATION TO THE SAID PROJECT PRIOR TO THE DATE OF APPROVAL OF THIS RESOLUTION.

WHEREAS, the National Government, through the Department of Transportation (DOTr) and the Light Rail Transit Authority (LRTA), extended the Light Rail Transit Line 1 (LRT-1) from Baclaran, Paranaque to Bacoor City, Cavite.

WHEREAS, the LRT Line 1 South (Cavite) Extension Project shall extend to two (2) stations in the City of Bacoor to be known as the Zapote Station and the Niog Station.

WHEREAS, the LRT Line 1 South (Cavite) Extension Project shall affect hundreds of families who are residents of the City of Bacoor.

WHEREAS, the DOTr, the LRTA, the Department of Human Settlements and Urban Development (DSHUD), the National Housing Authority (NHA) and the City of Government of Bacoor entered into a Memorandum of Agreement (MOA) which provides that the said national government agencies shall transfer funds to the City Government to implement the social preparation, structural mapping, resettlement, and relocation of families in the City of Bacoor that will be affected by the LRT Line 1 South (Cavite) Extension Project.


WHEREAS, considering that the City Government lacks the required human resources to perform the relocation and



WHEREAS, the City Mayor is authorized by law to sign the said contracts in behalf of the City.


WHEREAS, the City Mayor seeks the authorization of the Sangguniang Panlungsod to enter into and sign the Job Order Contract and to ratify those already signed.
