WHEREAS, on 26 February 2024, the Sangguniang Panlungsod passed City Resolution No. 2024-451 authorizing the City Mayor, Hon. Strike B. Revilla to sign a Memorandum of Agreement between City Government and QPax Traffic Systems, Inc. regarding the implementation of the Single Ticketing Program in the City of Bacoor.

WHEREAS, on the same date, the Sangguniang Panlungsod also passed City Resolution No. 2024-451A authorizing the City Mayor to sign a Data Processing Agreement with QPax Traffic Systems, Inc. on behalf of the City Government of Bacoor. This agreement is in connection with the sharing and processing of personal data arising from the use of QPax Traffic Systems, Inc. and the Bacoor City's interconnectivity with the Land Transportation Management System (LTMS) and/or other applicable database or system of the Land Transportation Office (LTO).

WHEREAS, on 03 April 2024, City Mayor Strike B. Revilla signed the Confidentiality and Non-Disclosure Agreement on behalf of the City Government of Bacoor with the QPax Traffic Systems, Inc. to ensure that both parties agreed to take responsible measures to protect the confidentiality and security of the disclosed information.

WHEREAS, the Sangguniang Panlungsod reviewed the said Confidentiality and Non-Disclosure Agreement and decided to ratify the same.
