A RESOLUTION APPROVING CITY OF BACOOR URBAN DEVELOPMENT AND HOUSING BOARD (CBUDHB) RESOLUTION NO. 1, SERIES OF 2024 ENTITLED: "A RESOLUTION ALLOCATING FUNDS TO THE POST RELOCATION LIVELIHOOD PROGRAM IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (Php500,000.00) AND ENDORSING TO THE SANGGUNIANG PANLUNGSOD THE APPROVAL OF THE AUTHORITY OF THE CITY MAYOR-HON. STRIKE B. REVILLA AND THE CITY TREASURER TO DISBURSE FUNDS FOR THE SAID PROGRAM FROM THE AVAILABLE FUNDS OF THE SOCIALIZED HOUSING TRUST FUND".

WHEREAS, on 24 April 2024, the Sangguniang Panlungsod received a letter from the Office of the City Mayor requesting the city council to pass a resolution approving City of Bacoor Urban Development and Housing Board (CBUDHB) Resolution No. 1, Series of 2024 entitled: "A Resolution Allocating Funds To The Post Relocation Livelihood Program In The Amount Of Five Hundred Thousand Pesos (Php500,000.00) And Endorsing To The Sangguniang Panlungsod The Approval Of The Authority Of The City Mayor-Hon. Strike B. Revilla and the City Treasurer to disburse the said funds intended for the aforementioned program from the available funds of the Socialized Housing Trust Fund.
