WHEREAS, on 12 May 2024, the Office of the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign a Mobile Payment Solutions Agreement and Mutual Confidentiality and Non-Disclosure Agreement on behalf of the City Government of Bacoor with G-Xchange, Inc. (GXI) for the availment of the payment services of GXI.

WHEREAS, GXI is duly licensed by the Bangko Sentral ng Pilipinas (BSP) as a licensed remittance agent and E-Money Issuer (EMI) that handles electronic money (e-money) issuance, remittance services and mobile payment solutions under the G-Cash brand.

WHEREAS, the City Government of Bacoor desires to accept payments from its taxpayers through the G-Cash Mobile Payment Solutions.

WHEREAS, the draft copies of the Mobile Payment Solutions Agreement (MPSA) and of the Mutual Confidentiality and Non-Disclosure Agreement (MCNDA) were submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration. Draft copies of the proposed MPSA and MCNDA are incorporated hereto and will be made an integral part of this Resolution.
