A RESOLUTION EXPRESSING THE PROFOUND SYMPATHY AND SINCERE CONDOLENCES OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOR, CAVITE ON THE DEMISE OF FORMER COUNCILOR BAYANI MASCARDO DE LEON AND HONORING THE MEMORY OF HIS EXEMPLARY AND DISTINGUISHED SERVICE TO THE PEOPLE OF THE CITY OF BACOR, CAVITE.

WHEREAS, Bayani Mascardo De Leon became a councilor of the former Municipality of Bacoor, Cavite in 2007 and became Chairperson of the Committee on Housing and Land Utilization and the Committee on Peace and Order of the Sangguniang Bayan.

WHEREAS, as a member of the Sangguniang Bayan and of the Sangguniang Panlungsod when the City of Bacoor, Cavite was created due to the approval of Republic Act No. 10160 (the "Charter of the City of Bacoor, Cavite") on 23 June 2012, Councilor De Leon authored several landmark pieces of local legislation that Bacooreños are still benefiting from to this day. Among the ordinances that he shepherded to approval are:

(1) Municipal Ordinance No. 3-2008 (AN ORDINANCE PROHIBITING ILLEGAL FISHING ACTIVITIES AND OTHER DESTRUCTIVE FORMS OF FISHING AS WELL AS FISHING IN FISHERY RESERVES, REFUGE AND SANCTUARIES WITHIN 15 KILOMETERS FROM THE SHORELINE AND/OR TERRITORIAL JURISDICTION OF BACOR, CAVITE AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.)

(2) Municipal Ordinance No. 6-2009 (AN ORDINANCE REGULATING THE INSTALLATION AND MAINTENANCE OF DISTRIBUTION LINES OF VARIOUS PUBLIC UTILITIES IN THE MUNICIPALITY OF BACOR.)

(3) Municipal Ordinance No. 21-2009 (AN ORDINANCE CREATING A TRAFFIC DECONGESTION SCHEME TO BE KNOWN AS THE "SOLIDARITY ROUTE" IN THE MUNICIPALITY OF BACOR, CAVITE.)

WHEREAS, the ebullient personality of Councilor De Leon gave otherwise drab or tension-filled public hearings conducted by the committees he chaired an appropriate level of levity which led to a swifter completion of the tasks that were assigned to him by the Sanggunian.
