**A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED BY MRS. MYLENE REMOJO FERMANES OF BARANGAY MOLINO I, AGAINST BARANGAY VAWC DESK OFFICER MS. CRISTINA A. CLARITO OF THE SAME BARANGAY DUE TO THE AMICABLE SETTLEMENT OF THE SAID DISPUTE.**

**WHEREAS**, on 06 June 2024, Atty. Rexford D, Guevarra , Regional Director of the Commission on Human Rights, Regional Office IV-A , sent a referral letter to the Hon. City Vice Mayor Rowena Bautista-Mendiola, Presiding Officer of the Sangguniang Panlungsod thru an e-mail.

**WHEREAS**, an e-mail complaint was filed by Mrs. Mylene Remojo Fermanes (complainant) before the Commission on Human Rights against Barangay VAWC Desk Officer named Cristina A. Clarito (respondent) for the alleged neglect of duty as an officer. On 30 April 2024, Mrs. Fermanes reported before the Barangay Molino 1, the alleged domestic and economic abuse by her husband which is a violation of Republic Act 9262 (otherwise known as the "Anti-Violence Against Women and Their Children Act of 2004") but her complaint was allegedly neglected by the respondent.

**WHEREAS**, the aforementioned matter was referred to the Committee on Ethics, Appointments and Government Reorganization for committee hearing investigation.

**WHEREAS**, the Committee on Ethics, Appointments and Government Reorganization of the Sangguniang Panlungsod conducted a committee hearing on 13 June 2024 attended by the above-mentioned parties with regard the said allegations. At the end of the hearing, the parties agreed to
