A RESOLUTION SUPPORTING HEAVENLY CULTURE, WORLD PEACE, RESTORATION OF LIGHT – PHILIPPINES' (HWPL) EFFORT FOR THE RECOGNITION OF THE DECLARATION OF PEACE AND CESSATION OF WAR AS AN INTERNATIONAL INSTRUMENT OF PEACE.

WHEREAS, a letter dated June 20, 2024 was received by the Sangguniang Panlungsod from the Office of the City Mayor with regard the request of the Heavenly Culture, World Peace, Resurrection of Light (HWPL) to support the Declaration of Peace and Cessation of War (DPCW) as an international instrument of peace.

WHEREAS, with its headquarters located in Seoul, the Republic of Korea, HWPL is an international non-governmental organization dedicated to promoting peace, is associated with the United Nations Department of Global Communications (UN DGC) and has consultative status with the United Nations Economic and Social Council (UN ECOSOC).

WHEREAS, the 10 articles and 38 clauses that make up the Declaration of Peace and Cessation of War (DPCW), prepared to be submitted to the UN General Assembly this year, emphasize international cooperation based on interfaith dialogue and civic participation to create a culture of peace. The DPCW promotes principles of peace-building, such as the prohibition of the use of force and the development of friendly relations and peaceful dispute settlement.

WHEREAS, the City of Bacoor is aware that this declaration will provide a way to address the underlying causes of armed conflict as well as a comprehensive system for preventing, resolving, and maintaining overall peace.
