That the DONEE shall use the Donated Properties exclusively for public use, and the DONOR has the authority to revoke this Deed should the Donated Properties be utilized privately;

That each DONEE hereby accepts and receives this donation made in its favor by the DONOR and hereby expresses its appreciation and gratefulness for the kindness and generosity of the DONOR in recognizing the abovementioned goods.

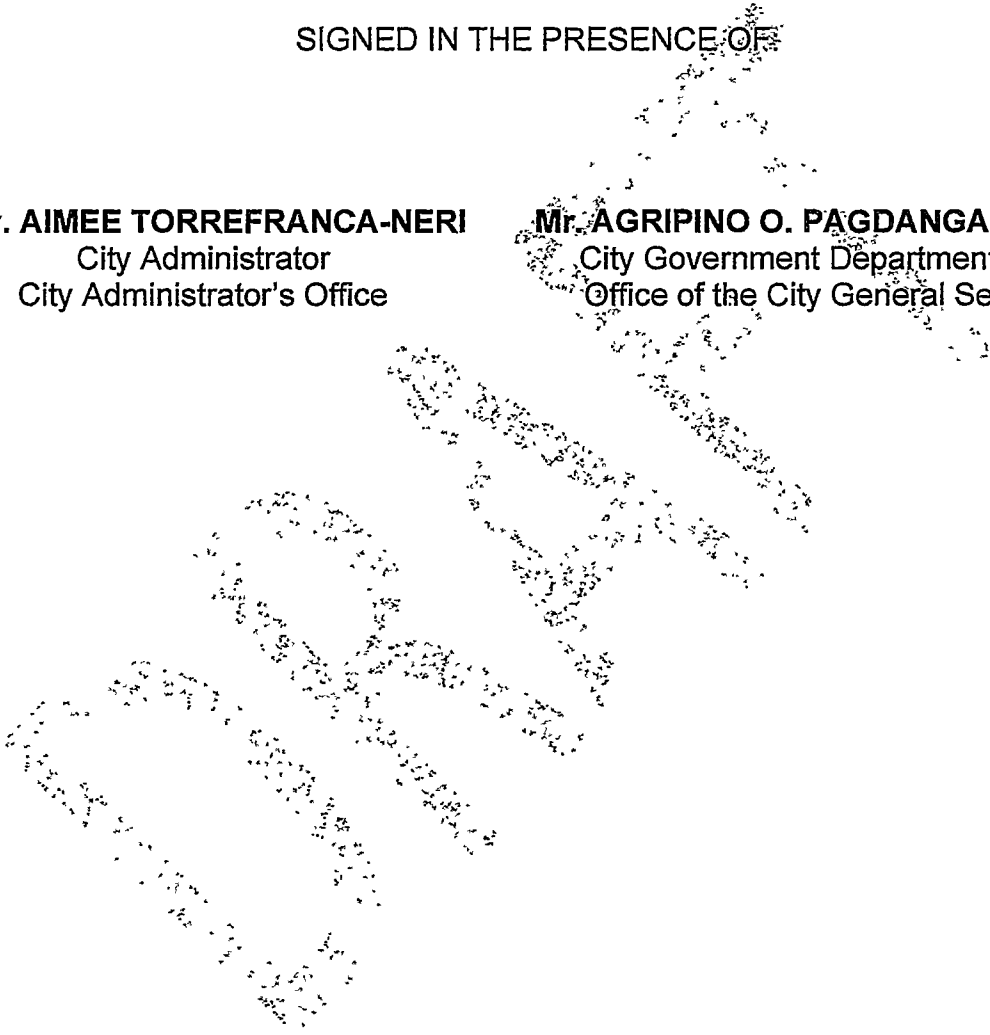
